When you come in, please bring with you the following items.

- -PA Driver's License physical license with photo on it. We cannot accept the temporary paper license.
- -PA Insurance in registrant's name.
- -Mileage of your car.
- -The cost for leased cars, or cars with no loan is \$259.00.
- -The cost for cars with a loan is \$295.00.
- -Cost for trucks vary by weight.
- **-We accept cash or check ONLY. No debit or credit cards.**

*PA inspection will need to be completed within ten days after we issue your PA plates.
